



## Koe tokoni fakapa'anga ki he ngaahi fakamole ki he mo'ui faka'aho.

'I he patiseti 'o e ta'u ni 2022, na'e fakahā ai 'e he pule'anga ha tokoni fakapa'anga ki he ngaahi fakamole ki he mo'ui faka'aho (Cost of living) 'I ha vaha'a taimi nounou, ki he kakai kotoa pe 'oku nau ma'u kakato 'a e ngaahi makatu'unga 'oku fiema'u ki he tokoni fakapa'anga ko eni.

Koe tokoni fakapa'anga ki he ngaahi fakamole ki he mo'ui faka'aho (Cost of Living Payment), e fika'i pe ia 'e he potungaue tukuhau (Inland Revenue) pea 'e totongi 'otometiki pe ia (automatically paid) mei he potungaue tukuhau.

### Ko e hā e ngaahi makatu'unga 'e malava ai ke ke ma'u ae tokoni ko eni?

'E lava ke ke ma'u 'a e tokoni fakapa'anga ki he ngaahi fakamole faka'aho (Cost of Living Payment) kapau na'e si'i hifo ho'o pa'anga hū mai i he \$70,000, i he vaha'a taimi 'o e 'aho 1 'o 'Epeleli 2021 kihe 31 Ma'asi 2022, pea kuo pau ke ke:

- ta'u 18 o lahi hake ai
- Nofo 'i Nu'usila ni pea ko e toko taha totongi tukuhau koe (New Zealand tax resident pea)
- 'oku 'ikai keke ma'u e tokoni 'uhila pe ivi fakaenatula, lolotonga e taimi Momoko (Winter Energy Payment) mei he Pule'anga.
