

Cancelling your child support

When to use this form

Use this form if you want us to stop your child support.

You cannot stop child support for any child you receive an unsupported child's benefit for.

If you are cancelling a child support formula assessment, anyone with at least 28% care of the child must also agree to cancel the child support.

If you are living in a relationship with the liable parent, you do not need to complete this form. Contact us with the date you started living together and we can stop your child support.
