

# Authorisation not to collect child support or domestic maintenance

## When to use this form

• You do not want Inland Revenue to collect payments owed to you by a liable person.

If there is more than one liable person you do not want us to collect payments from, complete a form for each.

If you want to cancel your child support you can do this in mylR or by completing a Cancelling your child support - IR107 form.

## **Notes**

- · You cannot ask us to stop collecting child support for periods when you received an unsupported child's benefit.
- You cannot ask us to stop collecting child support for periods prior to 1 July 2023 if you were receiving a benefit at a sole
  parent rate.
- You can ask us to stop collecting domestic maintenance or court-ordered lump sums of child support even if you received a
  benefit at the sole parent rate.
- You can ask us to stop collecting some or all of the payments owed to you. You cannot stop us from collecting any penalties
  owed by the liable person as these are owed to the government.
- Once you ask us to stop collecting payments, you cannot at a later date ask us to collect them. However, it is still possible for you to collect the payments owing by applying through the District Court.

## **Declaration**
