

Utu mō te utu oranga

I roto i te Tahua 2022, i whakaurua mai e te Kāwanatanga tētahi Utu Mō te Utu Oranga hei āwhina i te hunga e āhei ana me ā rātou utu noho o ia rā.

Ka aromatawaitia te Utu Mō te Utu Oranga, ā, ka utua aunoatia e Te Tari Taake.

Kei te āhei atu koe?

Ka āhei atu koe ki te Utu Mō te Utu Oranga mēnā i whiwhi koe i te \$70,000, iti iho rānei mai i te 1 o Āperira 2021 ki 31 o Maehe 2022, ka mutu:

- 18 ō tau, pakeke atu rānei
- he kainoho utu tāke koe nō Aotearoa e noho ana i Aotearoa, ā,
- kāore koe i te āhei atu ki te Utunga Pūngao o te Takurua.

Tērā ētahi tāngata kāore i te āhei atu ki te Utu Mō te Utu Oranga. Tirohia tā mātau paetukutuku mō ētahi taipitopito anō.

Ehara i te mea me tuku mai koe i tētahi tono. Ka tirohiohia e mātau ō whakaaturanga, ā, mēnā kei te āhei atu koe, ka whiwhi noa koe i tētahi Utu Mō te Utu Oranga.

E hia nui o te utu?

He \$350 te Utu Mō te Utu Oranga, ka wehea kia 3 ngā utunga.

Āhea ka utua te moni?

Mēnā e āhei ana koe, ka whiwhi koe i te moni mā ngā utunga ā-marama e 3, ka tīmata atu ā te 1 o Ākuhata 2022. Mō te nuinga o ngā tāngata, ko ngā rā utu e 3 ko te:

- 1 o Ākuhata, 2022
- 1 o Hepetema, 2022
- 3 o Oketopa (te rā mahi tuatahi o te marama).

Ka utua tonutia atu te moni ki tō kaute pēke o Aotearoa.

Ka tirohia e mātau mēnā kei te āhei atu koe ki te Utu Mō te Utu Oranga i mua i te utu i ia marama. Ka āhei atu pea koe mō te utunga 1, e 2, ngā mea e 3 katoa rānei.

Āhea kitea ai te moni utu i tāu pūtea pēke

Nā te rahinga, ka putuputu ngā utunga i te roanga o ia rā utu, me te aha, ka utua ētahi kiritaki i mua o ētahi atu.

Ka whiwhi ngā kiritaki nāna he pūtea pēke uniana whakamana hei te rā whai muri i te rā utu.

Ngā mea ka taea e koe hei whakarite mō ngā utunga

I mua o te 1 o Ākuhata, me mātua whakarite:

- kua oti tō aromatawai tāke moni whiwhi (kua tukuna rānei tō puka tāke 1R3) mō te tau tāke 2021-2022, ā,
- kei roto i ō whakaaturanga myIR ko tētahi kaute pēke whaimana o Aotearoa.
