Thank you for your request made under the Official Information Act 1982 (OIA), received on 23 March 2023. You requested the following:

In your annual KiwiSaver statistics - June 2012 to June 2022 dataset on your website is a table which shows the income of members and eligible population as at 30 June 2022 (the Demographics 3 table). The table includes (amongst other things) figures of the total number of KiwiSaver members by income band. Is it possible to obtain the number of KiwiSaver members by income band and by contribution rate? (i.e for the income band \$1 - \$10,000, the number contributing at a 3% rate, 4% rate etc.)

KiwiSaver members by income band and contribution rate

The table in Appendix A outlines the number of KiwiSaver members broken down by income band and contribution rate as at 31 March 2021. We have used the 2021 tax year, as returns for the 2022 tax year are still being finalised.

The income groupings are based on the total income for the year ending 31 March 2021 and includes Portfolio Investment Entity (PIE) income. PIE income from KiwiSaver may be the only income for some members. These members have been treated the same as other members and are grouped into the appropriate income band.

The "<=\$10,000" income band includes members who reported income loss for the year.

The contribution rate reflects the rate contributed through PAYE at the end of the 31 March 2021 tax year.
