The information you have requested is outlined in the tables on the following page. Dollar amounts are rounded to the nearest \$0.1 million.

Table 1 outlines the total aggregate monthly earnings (wages) of employees who used the NSW tax code for their employment.

Table 2 outlines the total amount of PAYE withheld from employees who used the NSW tax code for their employment. The PAYE amounts provided include the ACC earner premium.

Table 3 outlines the total number of employees who used the NSW tax code for their employment, broken down by month.

Tax statistics are subject to adjustments over time due to ongoing updates of additional tax information and/or improvements in data extraction.
