Dear

Thank you for your request made under the Official Information Act 1982 (OIA), received 19 January 2022. You requested the following:

Is it possible for you to provide data on tax losses that are carried forward? Specifically, I was hoping to obtain the value of losses that are currently carried forward in the agricultural sector (in the most recent year available). Again, if possible, if this could be broken down to the industry segments (e.g. dairying, fishing, etc) that would be helpful.

Information to be released

The tables in Appendices One and Two on the following pages provide information on losses carried forward from the financial years ending 31 March 2020 through to 31 March 2021. The information was extracted from Inland Revenue systems on 1 February 2022.

Data on losses carried forward presented in these two appendices is extracted from individual tax returns (IR3), company tax returns (IR4) and trust and estate tax returns (IR6). Industry classification has been done in a manner consistent with that used in our response to your OIA request sent on 13 December 2021 on tax and income in the agricultural sector, noting that industry classifications for some taxpayers are not held.

Appendix One presents total unrestricted losses that were carried forward from the 2019-20 income year into the 2020-21 income year. This total excludes residential rental income losses, which from the 2019-20 income year onwards are ring-fenced. Appendix Two presents the ring-fenced residential rental losses.
