Thank you for your request made under the Official Information Act 1982 (OIA), transferred from the Ministry of Business, Innovation, and Employment to Inland Revenue on 8 September 2023. You requested:

(...) What are the different child support costs per ratio of earnings per child per percentage or care? (...)

The child support formula assessment calculation (the formula) takes various factors into consideration. The care cost percentage and child expenditure values are two of these factors.

The formula uses a scale of costs, expressed as percentages of child support income, which reflects the expenditure involved in raising children. These percentages vary with the number of children, the age of the children (the percentage being higher for children over 12 years), and the total income of the parents. As income rises, the percentages progressively decline to reflect that the proportion of income spent on children declines as income rises. Given that the additional expenditure becomes increasingly discretionary as income rises, the formula also includes a cap on the amount of child support payable.

The formula takes the before tax income of the parents, subtracts allowances for their own living costs and other children they support. The amount payable to the person(s) providing care of the child is based on the combined incomes of the parents and their proportions of that combined income and care of the child.

The care cost percentage factor relates to the proportion of ongoing daily care that a person provides for the child. The calculations are set out in the following table taken from Schedule 2 of the Child Support Act 1991 (CSA):

Proportion of ongoing daily care	Care cost percentage
0 - 27%	0%
28 - 34%	24%
35 - 47%	25% plus 2% for each percentage point over 35%
48 - 52%	50%
53 - 65%	51% plus 2% for each percentage point over 53%
66 - 72%	76%
73 - 100%	100%

The child expenditure factor is calculated using the combined incomes of the parents (after allowances have been deducted) and uses set tables, which are adjusted each year, as set out in Schedule 3 of the CSA.
